The Planning Commission met fourteen times during 2017: twenty-four meetings were scheduled at the beginning of the year; ten were cancelled due to holidays or lack of agenda items.

John Tracey was elected chairman on January 9, 2017 and Dawn DiDonato-Burke was elected vice-chair at the reorganization meeting. Chad Wallace, Charles Halboth and Craig Bryson served on the Commission.

During 2017, Steve Ware of Keystone Municipal Services served as the Township Planning and Zoning Administrator in January and the first meeting in February, Jim Majewski served as the Township Director of Planning and Zoning for the remainder of the year; Mark Eisold and Maryellen Saylor of Boucher & James served as the Township Engineer; and Barbara Kirk of Hill Wallack served as the Township Solicitor for the Planning Commission. Jeffrey Benedetto served as the Board of Supervisors Liaison for the entire year.

The Planning Commission reviewed and recommended approval of proposed Zoning Ordinance Amendments to impervious surface requirements, fencing, expiration of variances, and accessible parking; reviewed and recommended approval of proposed changes to property maintenance and Building Code references in the Township Code; and reviewed and discussed amendments to the draft Township Comprehensive Plan update.

The Planning Commission heard a presentation of the Yardley Borough Act 537 Plan by the Township Sewer Engineer and recommended that the Plan be advertised for public review and comment subject to the approval of the Sewer Authority.
