The Planning Commission met ten times during 2015: twenty-four meetings were scheduled at the beginning of the year; fourteen were cancelled due to scheduling conflicts or lack of agenda items.

John Pazdera was elected chairman on January 12, 2015 and served in this position through the May 11, 2015 meeting. Dean Dickson was elected vice-chair at the reorganization meeting, on June 22, 2015 was elected chairman and served in this position for the remainder of the year. John Tracey served on the Commission, on June 22, 2015 was elected vice-chair and served in this position for the remainder of the year. William Clark served on the Commission for the entire year. Karen Friedman served on the Commission through the May 11, 2015 meeting. Dawn DiDonato-Burke joined the Planning Commission at the June 22, 2015 meeting, and served in this position for the remainder of the year. Charles Halboth was appointed to the Planning Commission, and served in this position for the remainder of the year.

During 2015, Steve Ware of Keystone Municipal Services served as the Township Planning and Zoning Administrator, Mark Eisold, Maryellen Saylor and Justin Geonnetti of Boucher & James served as the Township Engineer, and Nathan Fox and John Koopman of Begley, Carlin & Mandio served as the Township Solicitor for the Planning Commission.

During 2015, the Planning Commission recommended adoption of the Comprehensive Master Plan Update, and reviewed and discussed two (2) proposed Zoning Ordinance Amendments; one (1) to the O/R (Office/Research) Zoning District and one (1) to the HARB. No amendments were recommended to the Township Zoning Ordinance, or Subdivision and Land Development Ordinance during 2015.

The Planning Commission held a Joint Workshop with members of the Historical Architectural Review Board (HARB) to discuss the development of the Historic Edgewood Village and other historic properties in danger of demolition.
