The Planning Commission met seven times during 2021: twenty-four meetings were scheduled at the beginning of the year; seventeen were cancelled due to holidays or lack of agenda items.

Tony Bush was elected chair, Ross Bruch was elected vice-chair, and Adrian Costello was elected secretary at the reorganization meeting on January 25, 2021. Dawn Stern and Tejinder Gill also served on the Commission.

Jim Majewski served as the Township Director of Planning and Zoning; Andrew Pockl of Remington & Vernick served as the Township Engineer; and Barbara Kirk of Hill Wallack served as the Township Solicitor for the Planning Commission. Daniel Grenier served as the Board of Supervisors Liaison.

During 2021, the Planning Commission reviewed 1 Subdivision & Land Development Plan, 2 Conditional Uses, 2 Minor Subdivisions, 2 Lot Line Changes, 2 Informal Sketch Plans, and 1 Sewage Facilities Planning Module. The Planning Commission also discussed the bike paths proposed for the Newtown to the D&L Canal - Trail Feasibility Study by the Bucks County Planning Commission.
