PRETTY BIRD CAFÉ-UPDATE

Pretty Bird Café in Yardley Borough has addressed its accessibility issues by placing a sign asking disabled patrons to ring a bell for accessible entrance into the cafe. This will allow employees to open a side door to let people in without going onto the front porch.

There is also an issue with access to the ramp from the back parking lot. Ms. Huchler-Smith spoke to the owner of the building, Mr. Tim Foster, and they discussed the need for a 3 foot striped area to allow for access to the ramp leading to the cafe. He explained that restriping of the entire parking lot will be done upon completion of the new building located behind the parking lot.

GOALS FOR 2018

Formal goals for the Disability Advisory Board will be set during the February meeting.

BUILDING PLANS

Mr. Rogers has picked up building plans for a new memory care facility in Lower Makefield Township. The facility is to be built along Oxford Valley Road and Dorby Road. Mr. Rogers will review the plans and bring any comments to the next meeting.

In addition, Mr. Rogers will inquire about plans for the new Bagel shop that has opened near Giant.

Meeting minutes were completed by Ms. Huchler-Smith (secretary Megan Dorko was absent) but will be formally submitted by Ms. Dorko once reviewed by all.
