DAB AND SURROUNDING COMMUNITY INFO

Ms. Huchler spoke about surrounding community info. It seems only Middletown Township has a DAB. However, it has merged with Human Relations Committee which is more focused on discrimination: gender, race, employment, etc.

Ms. Huchler presented info regarding statistics of the township population. The 2010 Census shows 12.4% population over 65 years old. The Bucks 2040 Comprehensive plan shows in 2019 18.1% is over 65 in Bucks County.

Ms. Huchler wanted to present results from the 2010 survey the DAB had done to the new Board members. The results would probably still be applicable today.

Results:

Types of disabilities:

69 % had difficulty walking or were unable to walk

25 % have some hearing impairment

10 % have trouble speaking

13 % have seeing impairment

6% were mentally challenged

The majority of residents said that transportation and inaccessible buildings and/or other areas were their major concerns.

Ms. Huchler elaborated on the DAB mission which is to support township supervisors and all departments. As well as to educate community and provide resources to people with disabilities.

No curbs per say or obstructions seen on plans. Flat ground in front of all parking spaces.

Seems to be adequate parking in front of all retail buildings

Ms. Williams mentioned the Prickett project will be completed in phases.

Goals for 2022- Ms. Huchler asked the committee members to think about goals for 2022. We can go over at the next meeting. Potential suggestions included:

Literature for proper use of parking in handicapped parking spots

Fundraising ideas
