Pool:

Online registration for the 2018 Season is open! Last year's members have received their updated Membership Information packet and have begun registering. Key Fobs are being issued to members who have completed all the membership requirements. The discount period for LMT Residents has ended.

We are currently scheduling painting, inspections, chemical deliveries, cleanup and staffing. The staff has been hired and will be taking training over the next month. Assistant Managers have already started training and will be ready for a great summer season.

Engineers Report

At the May 2, BOS Meeting Andrew Pockl of Remington & Vernick Engineers gave a report.

This is what applies to P&R:

Snipes Athletic Fields – We conducted a tree count on Monday, 4-17-18, for all trees within the limits of disturbance that are 10" or larger. We have a balloon testing company under contract to complete a test to assess the visibility of the light towers. Test is based on weather and is tentatively scheduled for early next week. Completed walk through with Building and Planning Dept and Parks and Recreation Dept. on 5-01-18.

Memorial Park Expansion Grant – We have visited the site. Received executed agreement from DCED and provided qualifications to Terry for this work.

Woodside Road Bike Path – Will bid separate from Road Program. Need additional CAD information from roadway widening project.

Schuyler Park Tennis Courts – We inspected the paving at the tennis courts on 4-23-18 and have noted the serious cracking throughout. We are preparing a letter to review our findings and recommended costs for repairs. We anticipate completing the report by 5-16-18.
