 - Approval deferred due to lack of quorum.
- 2. Girl Scout Silver Award Project Dog Park Bridge
 - Alice Chase presented her Silver Award project: a bridge for the Dog Park made of composite decking (\$330 budget).
 - Board supported the project and the use of composite material.
 - Public Works will assist with stabilization if needed.
 - Project timeframe: May–August 2025.
 - Project approved.

 - PAA (Mike Spillane): Black and Orange Day scheduled for Saturday, including a Hit-A-Thon and fundraising events. Season is running well.
 - YMS: Hosted a successful tournament with excellent post-event cleanup.

Programming:

- Continued growth and diversification.
- Recent free yoga/fiesta event held at Memorial Park.
- Exploring more collaboration with the Police Department.

Facilities:

- o Field maintenance progressing well.
- o Large Dog Park section to reopen before Memorial Day.
