Meeting Called to Order at 728PM as all expected in attendance.

Motion to approve minutes of the July Meeting presented. Moved by Joe C, seconded by Jeff B. Passed Unanimously

## **Existing Business:**

- America 250 Event (Helen H) indicated a reduction to one weekend in late 2026 for a reenactment of the camps prior to the Battle of Trenton. Seeking 30 re-enactors and support from local BSA troops. Funding and approvals will be sought once the plan structure has been finalized
- Historic Research Survey (Joe/Cathy): Board of Supervisors briefed on 8/6/25. Thanks to Jeff Marshall. Spare budget applied to Deed research to augment findings for preservation efforts. Jeff B. prepared a Google Map of all properties
- **Demolition Ordinance Status**: Waiting for a date to be on the BoS calendar for a vote.
  - Justice House (743 River Road) appears to be safe from demolition.
  - 136 Old Oxford Valley is on a short-term reprieve as the development of the land is paused.
- Cataloguing Township Materials: (Dawn) The donation of a manuscript on 1150 Big Oak Road has been very helpful. Breezy Vale Farm (Wright Farm) will permit survey access
  - Grant to preserve donated map for \$5K has been submitted.
- **Slate Hill Cemetery: (Cathy H)** Update on grant from Bowman Hill for plants for educational beautification. September/October delivery for plants if the grant is accepted. GPNR report is complete, did go over budget by ~\$425. Headstone project being finalized for the repair of 100 headstones.
  - Ghost Tour in October: Still working on fundraising
  - Tree Removal: Over 10 trees removed over past month. Only one headstone was damaged.
  - Path Project: Eagle Scout Project potentially will need BoS approval.
  - QR Codes: 7 more pages added, hoping for new QR signs by the Ghost Walk

## **NEW BUSINESS**

- **2026 Historic Survey Grant**: Joe C suggested we apply and target structures built 1900-1939, which accounts for 261. Helen H suggested a determination, potentially by persons of importance who may have lived there. Jeff B volunteered to draft the RFP.
- A discussion regarding the neglect of Edgewood Village Buildings by their owner ensued. Motion to file a complaint with the BoS made by Joe C, 2nd by Dave V, passed unanimously.
