Our Future Goals

In our ongoing effort to encourage equal access in our community, some of the future goals of the DAB include:

- Engage community through networking at local events such as the 5K Anyway Color Fun Run for Accessibility
- Monitor all building plans and permits for commercial properties to ensure ADA compliance
- Continue to provide information for Emergency Management Services and alert systems
- Help raise funds for future accessibility projects in our community
- Coordinate with property owners to ensure compliance with ADA signage

What We Have Done

Some of the accomplishments of the DAB include:

- Completed construction of the inclusive playground at the Memorial Park
- Placed handicapped parking signs throughout township properties
- Completed installation of the audible traffic signal on Big Oak Road
- Installed accessible doors in the Township building and library
- Reviewed construction and renovation plans for commercial properties, and ongoing communication with all commercial property owners regarding the ADA
- Assisted in the development of the ADA Transition Plan along with the LMT Parks and Recreation Dept.
- Worked with the Parks and Recreation Dept. to install accessible pool lifts
- Supported 5-Mile woods accessible trail project
