The Planning Commission met nine times during 2025.

Colin Coyle was elected chair, Tejinder Gill was elected vice-chair, and Adrian Costello was elected secretary at the reorganization meeting on January 13, 2025. Anthony Bush and Ginni Torbert also served on the commission as members.

Jim Majewski served as the Township Community Development Director and Dan McLoone served as Township Community Planner; Patrick Foley of Remington & Vernick and Juni Alam/Kyle Turner of HRG served as the Township Engineers; Maureen Carlton of Curtin & Heefner served as the Township Solicitor for the Planning Commission. Daniel Grenier served as the Board of Supervisors Liaison.

During 2025, the Planning Commission reviewed one special exception, one lot line change, two major subdivisions, and one sketch plan.

The Commission also made recommendations for: sewage facilities planning modules component 4A – municipal planning agency review for two subdivisions, a new stormwater management ordinance, a SALDO amendment to align with the new stormwater management ordinance, a floodplain ordinance amendment, a SALDO amendment related to tree replacement, a SALDO amendment related to landscape and open land requirements, and for the Morrisville Sewage Facilities Management (Act 537) Plan. The commission also started to review a proposed renewable energy ordinance.
