The regular meeting of the Zoning Hearing Board of the Township of Lower Makefield was held in the Municipal Building on June 6, 2006. Secretary Malinowski called the meeting to order at 7:35 p.m.

He stated the Appeals scheduled to be heard this evening will be moved to June 20, 2006 with the exception of Appeal #06-1374 – Diane and Steven Bullard which will be moved to July 18, 2006. Mr. Toadvine stated he discussed the matter with Mr. and Mrs. Bullard who are present this evening and they indicated they would prefer to continue their Appeal to July 18, 2006 and have agreed to send a letter to Mr. Habgood indicating they want the matter continued to July 18, 2006 and will agree to waive the time limits pursuant to the Municipalities Planning Code. Mr. and Mrs. Bullard agreed.

Mr. Toadvine advised that the other three matters: Appeal #06-1375 – Michael and Colleen Attara, Appeal #06-1376 – Mr. Lopez/Mrs. Sordo, and Appeal #06-1377 – Y-Knot Knit will be on June 20, 2006. He stated there will be no further notices sent or advertisements.

Mrs. Gunsher asked if the other matters scheduled for June 20 will also be heard that evening, and Mr. Malinowski stated they will be heard that evening, but the continued cases will be heard first.


Ms. B. J. Rassler asked if any notification will be sent out on the time and date changes, and Mr. Malinowski stated no further notices will be sent out.
